These systemic issues create additional considerations when establishing liability in trucking accident cases.

Commuters traveling the Triangle's major freight corridors face daily challenges sharing the road with commercial vehicles. Safety experts recommend maintaining increased following distances, avoiding blind spots, and exercising particular caution during lane changes near large trucks. Understanding these safety practices becomes especially critical during peak freight movement hours when truck density increases significantly.

"The insurance and legal teams representing trucking companies begin their investigation immediately after an accident occurs," explained the firm representative. "Victims should not deal with trucking companies alone because these corporations have extensive resources dedicated to minimizing their liability, and unrepresented individuals often find themselves at a severe disadvantage during negotiations."

The enforcement of federal trucking regulations in North Carolina adds another layer of complexity to these cases. Violations of Federal Motor Carrier Safety Administration rules regarding driver qualifications, vehicle inspections, and electronic logging devices can establish negligence but require extensive knowledge to identify and prove. Additionally, the involvement of multiple insurance policies with varying coverage limits often complicates the compensation process.
